Enrollment Instructions

Welcome! Congratulations on enrolling in your retirement plan! The instructions below will help you enroll.

Your Plan has a Qualified Default Investment Alternative (QDIA). Information about the QDIA offered in your plan is listed in a notice located under the "Documents and Forms" menu once you login. You can make your own investment elections when you use SmartPlan described below.

Now let's get started! Follow these step-by-step instructions to enroll.

DEFAULT LOGON

- Logon to your account at <https://abidingwealthadvisors.com/login/>
- Select **RETIREMENT PLAN PARTICIPANT LOGIN** in the middle of the landing page
- You will be taken directly to your plan administrators secure website (for technical assistance please call MVP direct at 866-687-6877)
- Enter your Social Security Number as your **USER ID** (with no dashes and no spaces)
- Enter your Password which will be your birthdate in the format (MMDDYYYY) **and Click Logon**

MY eDELIVERY PREFERENCES

- Click on **Update Email Address** and enter your current email address, if necessary. We suggest you use a personal email address so if you ever left your employer, you will continue to receive email notifications. After updating your email address, click **SAVE** and then **SUBMIT**.
- The email delivery notifications allow you to receive an email confirmation of any web-based transaction you make. If you opt out of this delivery notification you will not receive a confirmation of any kind. We recommend Email Delivery notifications. Once you make your selections, click **SUBMIT**.
- You must consent to your elections. Click **"I Consent & Submit"**.

BENEFICIARIES

- Click **My Profile, Beneficiary Information** from the top menu
- Enter your Beneficiary Information and be sure to read the instructions completely. **Note:** If you are legally married, your spouse must be your beneficiary unless your spouse consents otherwise. See Documents and Forms for a Paper Beneficiary Form and an explanation.
- Click **Add Beneficiary** – Complete the information as indicated
- Once all beneficiary information has been entered, click **Continue**
- View your Beneficiary information and make changes if necessary. If you are satisfied with your beneficiary information, you must click **APPLY CHANGES** for your election to take effect.

GO TO SMARTPLAN!

You have a great tool called SmartPlan that allows you to understand the benefits of retirement savings, assess your retirement readiness, elect how much to contribute, and elect how you want your contributions to be invested. Go to "SmartPlan Interactive Tool", "Launch SmartPlan". Be sure to watch all of the very brief videos to help you on your way to greater retirement savings!

ENROLLMENT COMPLETE!

You can login and view your account each day. Your account balance will be updated daily by 10am.

Electronic Disclosures: If you use a computer as part of your work with the Plan Sponsor, then the documents listed above are considered “delivered” to you. Additionally, these and other documents such as Summary Material Modifications and Summary Annual Report may be delivered to you electronically under acceptable methods for electronic guidance by the DOL/ IRS. These Enrollment Instructions request you provide your email address under the **My Profile** section of your account login. You have the right to opt out of electronic delivery at any time by contacting your HR manager and requesting a paper copy of any of the required disclosures free of charge.

You may change your contribution election only as indicated by the Plan Administrator unless there is an unforeseen change in your financial circumstances. You may login to your account anytime and change your contribution election, but it will only take effect through your payroll deductions as allowed by the Plan Administrator. Please contact your Plan Administrator or HR Manager as to when contribution changes take effect.

If you wish to cancel your contribution or investment election, go to **Transactions** from the top menu, then **Web History**. If the word “Cancel” appears next to your transaction, you may cancel the web transaction. If the word “Cancel” does not appear, it has already been processed.

To make changes to your deferral amount and investment elections outside of SmartPlan

TO CHANGE DEFERRAL RATE/AMOUNT

- Click on **Transactions, Change Deferral/Rate Amount** from the main menu
- Select **Deferral Type** from the drop down menu. Your plan allows you to select a dollar amount or a percent for your deferral contribution. The amount you elect will be deducted from each paycheck. Once you make a selection, click on the box **Change Deferral Rate/Amount**
- Enter your contribution election, which can be any amount up to the IRS limits for your contribution under the **Current Value** column. *If your plan allows Roth the option will display.*
- Click **Submit Deferral Change**

TO CHANGE YOUR INVESTMENT ELECTIONS

Your contributions will be invested into the plan’s Qualified Default Investment Alternative (QDIA). *Information about the QDIA offered in your plan is listed in a notice located under the “Documents and Forms” menu.* However, if you wish to choose your own investment portfolio – please do the following:

- Click on **Transactions, Change Future Elections** from the top menu
- Select your investment percentages by placing the percentage of your contributions you want invested beside the investment name under the column labeled **New %**. You may click on the name of the fund, and a link will take you Morningstar, a financial program, where you can learn more about that investment. You may view more information about all plan investments by selecting **Investment Information** from the top menu, and then **Performance and Prospectus**.
- Once you are satisfied with your investment selections, select **Submit Investment Elections**.

Please enjoy the savings tables, it is our hope it will help you visualize a savings goal. Pick your years to retirement, select the monthly amount you can save, and the earnings you expect based on your risk tolerance to get a projection.
